### Silent Features

- Whole program will be delivered within 04 weeks with classes to be held from Monday to Thursday.
- It would be an advance level program with relatively faster pace so participants should have either basic knowledge of Islamic Banking or Shariah Standards or some experience of working in any Islamic Financial institution.
- Program trainers are either AAOIFI's master trainers or familiar with AAOIFI courses and related exams.
- After through discussion of all standards in 04 weeks, a final exam is scheduled in the next week to award the certificates to successful participants. 60% marks along with 80% attendance are main thresholds for certification.
- Final exam would be held physically at any of NIBAF campus. Participants may appear in exam with one week as per their convenience.
- This certification may help in appearing in CSAA but it is not mapped with it.
- Fee includes course fee, study material and Certification.
